

Summary of Proposed Ordinance relating to the Sale and Use of Fireworks

This summary fulfills Washington State Growth Management Act and King County Code (K.C.C.) 20.18.100 requirements for a “plain language summary.”

King County is proposing changes to the King County Code to prohibit the retail sale and personal use of fireworks in unincorporated King County. If enacted, this ordinance will protect people and property from the unexpected, and sometimes fatal, consequences of burns and fires from fireworks. Public fireworks displays that receive the proper permits would still be allowed, as would the sale and use of trick and novelty devices. The following is a summary of a draft proposed ordinance addressing these code changes.

Using on the definition of “fireworks” in RCW 70.77.126, novelty and trick devices (as defined by WAC 212-17-025 and includes devices such as party poppers and snappers) would continue to be allowed for sale and use. All other fireworks, including sparklers, would be prohibited for sale and use. State law considers sparklers the same as other consumer fireworks, such as ground spinners, cone fountains, and roman candles. Sparklers can be just as hazardous as other consumer fireworks when used by non-professionals, given that they burn at very high temperatures – about 2000 degrees Fahrenheit, which is as hot as a blow torch.¹ For public displays of fireworks: <ul style="list-style-type: none"> As with current code (K.C.C. 6.26.080), public displays of
